


We have reviewed the accompanying statement of unaudited standalone financial results of **LWS Knitwear Limited** ("the Company") for the quarter ended **31<sup>st</sup> December, 2019** being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 read with SEBI circular dated 05, July 2017.
